Public Entity: One-time relief package

One-time Relief package for vulnerable groups

The Public Entity Saba has implemented additional support measures for the community in order to alleviate the burden of costs related to the Covid-19 crisis, to continue assisting vulnerable groups in the community, and to look at a one-time contribution. This compensation is granted once per household and not per person.

The following conditions apply to be eligible for a one-time contribution:

1. You must be a fulltime resident of Saba
2. You have been affected by the covid-19 crisis during the period of March 13th, 2020 to present July/August, but was unable to qualify for any other relief packages (for example but not limited to unemployed persons, persons struggling with rent and utilities etc.)
3. You have a combined household income of (amounts based on the 2019 'ijkpunt sociaal minimum' of SZW):
 - One person household: less than \$718 after mortgages and rent;
 - Two person household: less than \$1,132 after mortgages and rent;
 - Three or more person household: less than \$1,455 after mortgages and rent;

Based on your information provided in this form, the Public Entity will assess your situation and determine if you are eligible for support, taking above conditions into consideration. The support will consist of a one-time contribution.

The regulation is implemented through the Public Entity Saba. Send this form completed and signed ultimately **by August 21st, 2020** to onetimerelief@sabagov.nl **with a copy of your valid identification card, salary slips of 3 recent months and proof of other sources of income**(per person in the household) as an attachment. If necessary, the Public Entity can request additional information from you.
