	Summary:	<p>The BES(t) 4 Kids program is working on strengthening the continuous learning/development line from Day Care to Primary Education (kindergarten). To further improve the transition from one learning institution to the other the method of High Scope has been chosen by Day Care, After School care and now also Primary School for kindergarten.</p> <p>By using the High Scope method children transitioning from one organization to the other, will be able to follow the curriculum from 0-6 years old. This method was chosen in 2019 for Day Care and After School care as it is a hands-on approach that embraces learning through play.</p> <p>SHS in 2023 starts the process to train the kindergarten staff in the High Scope method to fully implement the curriculum for school year 2023-2024. Apart of this training is to also send the teachers on an exchange to the Netherlands to visit schools who use this method of teaching.</p> <p>This proposal is to ensure that SHS can receive funding from the B4K program to fully support this initiative.</p>
